ORDINANCE NO. 2495

AN ORDINANCE <u>AUTHORIZING AND APPROVING AN ECONOMIC INCENTIVE AGREEMENT</u> (Shields Auto Center, Inc.)

WHEREAS, the Village of Rantoul, Champaign County, Illinois (the "Municipality") is a home rule unit under and pursuant to Section 6(a) of Article VII of the Constitution of the State of Illinois, and is authorized to exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, in accordance with and pursuant to Section 8-11-20 of the Illinois Municipal Code (65 ILCS 5/8-11-20), as amended, including by the power and authority of the Municipality as a home rule unit (collectively, the "Act"), the President and Board of Trustees of the Municipality (the "Corporate Authorities") are authorized to enter into economic incentive agreements in order to encourage the development or redevelopment of land within their corporate limits; and

WHEREAS, Shields Auto Center, Inc. (the "Developer") has proposed to develop an automobile sales and service facility (the "Project") on certain property to be owned by the Developer at 844 and 862 Broadmeadow Road and 815 Champaign Avenue within the Municipality (collectively, the "Property"); and

WHEREAS, the Developer is unwilling to acquire the Property and to undertake (or cause to be undertaken) the Project unless the Municipality agrees to rebate fifty percent (50%) of the increased portion of the sales taxes imposed by the State of Illinois pursuant to the Retailers Tax Act (35 ILCS 120/1 et seq.) that are generated by the Project at the Property and provided to the Municipality for a period of ten (10) consecutive years (the "Economic Incentive"), which the Municipality is willing to do; and

WHEREAS, there has been presented to and there is now before the meeting of the Corporate Authorities at which this Ordinance is adopted the form of a certain Economic Incentive Agreement (the "Agreement") by and between the Municipality and the Developer under and by which the Municipality agrees to provide the Economic Incentive to the Developer; and

WHEREAS, pursuant to the Act, the Corporate Authorities hereby make the following findings with respect to the Property and the Project:

- (a) The Property has remained significantly unoccupied or underutilized for a period of at least one (1) year;
- (b) The Project is expected to create or retain job opportunities within the Municipality;
- (c) The Project will serve to further the development of areas adjacent to the Property;
- (d) Without this Agreement, the Project would not be possible;
- (e) The Developer meets high standards of creditworthiness and financial strength;
- (f) The Project will strengthen the commercial sector of the Municipality;
- (g) The Project will enhance the tax base of the Municipality; and
- (h) This Agreement is made in the best interest of the Municipality; and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF RANTOUL, CHAMPAIGN COUNTY, ILLINOIS, as follows:

<u>Section 1</u>. That the Agreement be and the same is hereby authorized and approved.

<u>Section 2</u>. That for and on behalf of the Municipality, the Village President is hereby authorized to execute and deliver the Agreement, and the Village Clerk is hereby authorized to attest the same, with such insertions, changes or revisions in the form of such Agreement as may be approved by such Village President, such execution or acceptance thereof, as the case may be, to constitute conclusive evidence of such approval of any and all such changes or revisions therein from the form of the Agreement as authorized and approved by this Ordinance.

<u>Section 3</u>. That from and after the effective date of this Ordinance, the proper officers, employees and agents of the Municipality are hereby authorized, empowered and directed to do all such acts and things and to prepare, execute, deliver, acknowledge and file all such supplemental documents, agreements, certificates, forms, receipts and other instruments as may be necessary to accomplish the purposes of this Ordinance in accordance with the respective terms, conditions and undertakings of the Agreement.

This Ordinance is hereby passed, the "ayes" and "nays" being called, by the concurrence of a majority of the members of the Corporate Authorities then holding office at a regular meeting held on the date set forth below upon a roll call vote as follows:
